CONTRACT TO PARTICIPATE IN MOTORCYCLE RACING EVENT AND/OR ACTIVITY

1. I (PLEASE PRINT) _____ (RIDER)
I _____ (PASSENGER)

HEREBY AGREE with the persons, organisations and bodies corporate whose names appear in Schedule 1 (hereinafter collectively called "the organiser") that I am by this agreement entitled to participate in the motor cycle activity/race meeting listed in Schedule 2 (hereinafter called "the race meeting") at the venue listed in Schedule 3 (hereinafter called "the venue") on the terms and conditions set out in this document.

ACKNOWLEDGMENT OF RISKS, DANGERS AND OBLIGATIONS

2. I **ACKNOWLEDGE** that the sport of motorcycle racing is dangerous and that by engaging in the sport and participating in the track day I take and am exposed to certain risks and dangers and am under certain obligations as follows:
- a) that I may be injured, physically or mentally, and may be killed;
 - b) that my machinery or equipment may be damaged, lost or destroyed;
 - c) that other riders may ride dangerously or with lack of skill;
 - d) that track or event conditions may be hazardous and may vary without warning or predictability;
 - e) that organisers, officials, landowners/track operators and any agents or representatives of those in charge of track day are frequently obliged to make decisions under pressure of time and/or events;
 - f) that any policy of insurance of or in respect of my life or physical or mental health may be avoided;
 - g) that there may be no or inadequate facilities for treatment or transport of me if I am injured;
 - h) that I have an obligation to myself and others to ride safely and within the rules.

INDEMNITY GIVEN TO ORGANISERS

3. **IN CONSIDERATION** of the acceptance of me as an entrant in the track day I **AGREE TO INDEMNIFY** the organisers and each of them in the following manner:
- a) that I participate in the track day at my sole risk and responsibility;
 - b) that I accept the venue as it stands with all defects hidden or exposed;
 - c) that I indemnify and hold harmless the organisers, their respective servants, agents or officials against any actions or claims which may be made by me or on my behalf or by other parties for or in respect of or arising out of my death or any injury, loss or damage caused to me or to my machinery or equipment whether caused by negligence, breach of contract or in any other manner whatsoever.
